Teen Acne Inspires Gordon Skincare and Massage Career

It had to have been a transition for a Colorado couple to relocate to Northwest Nebraska. Five years ago, McKenzie Harrison and her husband Brandon moved from Brighton, Colo. to Gordon. The Harrisons had known each other since they were little because their families were great friends. "We didn't start dating until I was about 26. We have now been married 12 years," she explained. Following high school, McKenzie went to massage school in 2007, then went on to aesthetic school in 2009. "I received my training certificate from Denver School of Massage Therapy. I received my certificate of aesthetics at Xenon International Academy in Aurora," she added.

Mckenzie has special licenses in microneedling and chemical peels, hot stone massage and injury work.

"I always wanted to help people feel their best. I suffered from acne as a teenager so that led me to finding resources to help people with their acne," explained Mckenzie, who worked at a few different day spas in Colorado before moving to Nebraska. She now owns and operates "Cherish: the Skincare Studio", based in Gordon at 101 W. 9th Street. She set up shop in October of 2021.

to Massage Therapy, Waxing, Facials, Waxing, Eyelash lift & Tinting, Demarplaning, Eyebrow and Lash Tints, Microdermabrasion & Chemical Peels. . Other services included a Dermaplanning, Deluxe Facial which removes the vellus (peach fuzz) hair from the face as well as resurfaces the top layer of the dead skin. Last but not least Jet Plasma. A Jet Plasma pen is a handheld plasma device that uses a cool atmospheric temperature to tighten and lift and reduce sun damaged and discoloration.

NRPPD Announces Resignation of Manager Chance Briscoe

Northwest Rural Public Power District (NRPPD) announced that Chance Briscoe will resign from his position as General Manager effective at the end of the year. Briscoe will be relocating to Minnesota in January 2026 to assume the role of Chief Executive Officer of BENTO Electric, a rural, non-profit electric cooperative serving south-central Minnesota.

Briscoe has served as General Manager of NRPPD since 2014. He joined the District from Colorado, where he was serving as Chief Financial Officer of KE Electric, and succeeded long-time General Manager Rolland Skinner. During his 12-year tenure, Briscoe worked closely with the NRPPD Board of Directors and employees to guide the District through significant operational, financial, and regulatory challenges while maintaining a strong focus on affordability and service reliability for customers.

Early in his tenure, Briscoe led a comprehensive rate

restructuring effort in collaboration with the Board of Directors at the time. As a result, NRPPD achieved meaningful long-term rate stability. In 2014, the average residential rate was 16.5 cents per kilowatt-hour. As of the end of 2024, the average residential rate stood at 13.8 cents per kilowatt-hour—lower than it was a decade earlier.

Briscoe also championed numerous technology advancements at NRPPD aimed at improving customer service and operational efficiency. These initiatives included the implementation of remote account reconnects, online and mobile account access, credit card payment processing, and an outage management system, among other enhancements.

During Briscoe's tenure, NRPPD and other Nebraska Tri-State members faced significant challenges related to their power supply contract with Tri-State Generation and Transmission Association, which extended through 2050. Briscoe joined NRPPD following the loss of a lawsuit seeking to exit that contract. In 2019, when Tri-State became federally regulated by the Federal Energy Regulatory Commission, NRPPD again elected to pursue an exit from the 2050 contract. That effort remains ongoing, and Briscoe has expressed confidence that NRPPD will successfully achieve an exit by the end of 2026.

The NRPPD Board of Directors has contracted with a national association to conduct a nationwide search for the District's next General Manager. The Board anticipates hiring a permanent replacement by the summer of 2026. In the interim, the Board has engaged Kory Johnson to serve in an interim leadership role. Johnson is a retired General Manager with extensive experience in rural, non-profit electric utilities. Most recently, he served as General Manager of Agralite Electric Cooperative and currently resides in Rapid City, South Dakota.

Reflecting on his time at NRPPD, Briscoe said, "I am grateful to the current and former Board Members for allowing me to serve as the General Manager for the past 12 years. I especially want to thank the employees of NRPPD who have supported me during my time at NRPPD and provide extremely dedicated service to the customers of NRPPD, day in and day out. I am excited to start the next chapter of my career but will miss working with the Board and employees and wish them nothing but the best as NRPPD continues into the future."

The NRPPD Board expressed its appreciation for Briscoe's leadership and service to the District and wished him success as he begins this next chapter in his career.
